The UK withdrew from the EU at 11 p.m. on 31 January 2020 (“exit day”).

The Withdrawal Agreement provides for there to be a transitional period that expired on 31 December 2020 (“IP completion day”). In broad terms, EU law continued to apply in the UK during that period and rolled over into domestic law as retained EU law on IP completion day.

Article 137 of the Withdrawal Agreement provides for an important exception to that general rule: Regulation (EU) No 1307/2013 (the “Direct Payments Regulation”) did not apply in the UK for claim year 2020. That carve out also applies to the associated delegated and implementing EU legislation.

The effect is that former EU CAP law will be rolled over into domestic law in 2 phases:

- The Direct Payments Regulation and associated delegated and implementing EU legislation became retained EU law under the Direct Payments to Farmers (Legislative Continuity) Act 2020 on exit day, and
- All other EU CAP legislation became retained EU law under the European Union (Withdrawal) Act 2018 on IP completion day.

Applicants should note that retained EU law was, on being rolled over, subject to ‘operability’ changes that ensure that CAP legislation will continue to work under domestic law. Corresponding changes have been made to Scottish implementing legislation.

Article 138 of the Withdrawal Agreement provides that all ongoing programmes and activities committed under the Multiannual Financial Framework funding period 2014 – 2020 (or earlier funding periods) remain subject to EU law (not retained EU law) until closed. This means that rural development commitments entered into before 2021 must continue to meet the requirements of EU law rather than retained EU law.

The EU legislation quoted in the “Declaration and Undertakings” will continue to apply in Scotland on that basis described above. It may be subject to further changes at EU or national level (as appropriate), and therefore references to the legislation as amended from time to time should be understood on that basis.
