

**Agri-Environment Climate Scheme landlord declaration form.**

This form must be completed only where:

- you have a tenancy or licence covering the full duration of the contract and associated monitoring period and a copy of the lease or licence (or for official sub-tenants of a croft, a copy of the letter issued by the Crofters Commission confirming the approval of the sub-let and its duration) has not been submitted as part of the application (sections 1,2 and 3 must be completed)
- OR**
- you have a tenancy or licence which does not cover the full duration of the contract and associated monitoring period (sections 1,2 and 4 must be completed)
