## 1.. Seeking endorsement for options or capital items outwith their target area.

### Introduction

A new element in the Agri-Environment Climate Scheme is that many management options and some capital items have been spatially targeted.

This means they will only be available in parts of the country where they will deliver the greatest benefit.

You can find out which options are available on the holdings that form part of your farm business using our targeting tool (link below). Please note that updates to spatial targeting may change the options that you're eligible to apply for.

### [Targeting tool](#)

In exceptional circumstances, you may apply for a management option or capital item that is not targeted on your holding. However, you must meet the criteria for endorsement outside the target area, as shown in Table 1 (below) and you must obtain an endorsement before submitting your AECS application, as explained below.

Requests for endorsements should be made to Scottish Natural Heritage (SNH) or Forestry Commission Scotland (FCS), depending on the management option or capital item concerned.

### Natural heritage designated sites

These include Sites of Special Scientific Interest (SSSI) and Natura sites. Natura sites are Special Protection Areas (SPA) and Special Areas of Conservation (SAC).

If you wish to carry out management to benefit an SSSI and / or Natura site, you can apply for any management options (with the exception of the Hen Harrier Grassland Management option which is only available in Orkney) or capital items which will benefit the special features of the site, even if they do not appear on your list of targeted options.

This includes circumstances where the work that will benefit the site's features takes place on your holding but partially or wholly outside the site itself.

You will need to submit an endorsement from Scottish Natural Heritage with your application. This needs to confirm that the option or capital item you have chosen will benefit the features of the designated site.

You can visit the Scottish Natural Heritage website to check the location of the designated site.

### [Designated site](#)

You are strongly advised to seek advice from Scottish Natural Heritage before drafting an application for a designated site. If you do not, and Scottish Natural Heritage has significant issues with the management you propose for the designated site, this may prejudice the success of your application.

### Contact Scottish Natural Heritage

If you include ineligible items in your application it will be rejected and you should first read the scheme guidance on [designations](#) before applying.

You should also read the terms and conditions laid out in [How to Apply](#) guidance.

### How to request an endorsement

If you wish to seek an endorsement then you must submit a request to Scottish Natural Heritage or Forestry Commission Scotland.

You will need to request an endorsement in plenty of time, to ensure Scottish Natural Heritage or Forestry Commission Scotland have time to assess it and respond to you before the AECS application window closes.

If you are permitted an endorsement, you must submit this with your AECS application.

Please contact FCS directly for further information on its endorsement process.

Check Table 1 below to see whether the management option or capital item you wish to apply for this year is listed and to check which organisation to contact. Only those management options or capital items listed in Table 1 will be considered for endorsement.

In the SNH endorsement form, you are asked to explain briefly how each option or capital item meets the criteria for endorsement. Scottish Natural Heritage or Forestry Commission Scotland will clarify whether you need to provide any further evidence.

In most cases the endorsement will confirm that the options you have selected are eligible, will benefit the objectives of management and that the location in which you wish to carry out the management is appropriate.

Management or Restoration of Hedgerows	The hedgerow has been created under a legacy agri-environment scheme	SNH
Unharvested Conservation Headlands for Wildlife	Presence of corn buntings according to existing records	SNH
Wader Grazed Grassland Wader and Wildlife Mown Grassland	You must meet <b>one of</b> the criteria below: - you have provided evidence, from records held by an independent national wildlife organisation (e.g. RSPB), that curlew, lapwing or redshank have been recorded breeding on the proposed management areas in at least one breeding season within the last five years  (Where data does not exist for the proposed management area then you may commission independent surveys to establish that curlew, lapwing or redshank were breeding in the proposed	SNH

You must include this statement when submitting the endorsement form to SNH.	SNH
Moorland Management Stock Disposal Away Wintering Sheep Summer Hill Grazing of Cattle	Presence of a habitat on your holding that would benefit from management under one or more of these options, including blanket bog and wet heath	SNH
Tall-herb Vegetation Management	Presence of tall herb vegetation which would benefit from management under this option	SNH
Control of Invasive Non-native Plant Species	The land on the holding is part of an area-wide, coordinated strategy for controlling invasive plants, or you are first land manager in your area to have the plant species on your land	SNH
Rhododendron Control	The land on the holding is part of an area-wide, co-ordinated approach for controlling a whole population of rhododendron; and work is essential to control or prevent invasion of a notable site (Special Area of Conservation, Site of Special Scientific Interest or ancient semi-natural woodland site); and/or necessary to secure another investment in controlling a population of rhododendron	SNH/FCS
Any management option or capital item to benefit a designated site	The choice and location of option(s) and/or capital item(s) will benefit the feature(s) of the designated site	SNH
Any management option or capital item to benefit pearl mussels	The choice and location of options and/or capital items will benefit freshwater pearl mussels out-with a designated site	SNH

Management option	Criteria for endorsement	Endorsing organisation
Species rich grassland Habitat Mosaic	<p>If the land proposed for management under either option is hill and upland rough grazing, you can only apply for these options if you are awarded an endorsement from SNH.</p> <p>The endorsement application requires you to provide supporting evidence that target habitats are present, by submitting either:</p> <ul style="list-style-type: none"> <li>• a Phase 1 habitat survey that demonstrates the presence of the target habitats,</li> </ul> <p>or</p> <ul style="list-style-type: none"> <li>• an existing National Vegetation Classification survey demonstrating the site contains the target species</li> </ul> <p>This evidence must accompany your Endorsement form.</p>	SNH
